 - c) For producing 90% results in a theory paper: Rs 300/- Cash Award.
 - d) Department-wise, Yearly, BEST TEACHER AWARD: Rs 2000/- Cash Award.
 - e) Professional Society Life Membership Fee 50% paid by the Management for Faculties with minimum two years of service at the Institution (Maximum One Professional Society per Staff Member).
 - f) Paper publications in National Conferences 50% TA, 100% Registration Fees,
 On Duty and Rs 500/- Cash Reward.
 - g) Paper publications in International Conferences 100% TA, 100% Registration Fees, On Duty and Rs 1000/- Cash Reward.
 - h) Faculties undergoing Full-time, higher Education, fellowships, advanced studies, collaborative research (PhD/ME/MTECH Etc) – Fees 100%, 50% Salary against 5 Years Service Agreement on completion of degree.
 - i) Faculties undergoing Part-time, higher Education (PhD/M.Pharmacy/ P.G Dip etc.) Fees 100%, 100% Salary against 3 Years Service Agreement on completion of degree.
